TAM presented 11 total exhibitions during FY24, including Impressionism at TAM, a partnership with Tacoma Arts Live to highlight Impressionism in our collection, always a popular draw among visitors; and Soft Power which used primarily textiles as a medium to express cultural heritage, & amplify social criticism.

Museum services includes the TAM store, TAM Café, and visitor services. The store features local artist designed jewelry, ceramics, and books by local authors and reflect current exhibitions. TAM café offers freshly made entrees and coffee sourced from local roasters. TAM rents museum facilities to local business group meetings, community service organizations, exhibition openings, and private events.

TAM's education program empowers visitors to find and create meaning with art in order to build an empathetic and collaborative community through programs and tours, in gallery activities and audio tours, art workshops and creative opportunities. During one of TAM's most popular programs, Neighborhood Nights, the museum is free and open to the public every Thursday from 5-8pm.
